- All veterans on active duty, honorably discharged or retired from any branch of military service may apply for Associate Membership. Also requires copy of DD214.

If discharged, I am in receipt of an honorable discharge or DD214. Attached is a copy of my last DD-214. "Honorable service" will be defined by the last DD-214 or Certificate of Discharge that the applicant received. General Discharge under Honorable Conditions is acceptable. By signing I am authorizing the National Director, Marine Corps League, to obtain an un-redacted copy of my latest DD Form 214 from the custodian of Official Military Personnel Files (OMPF), and/or verification of honorable service if deemed necessary to verify my eligibility for regular membership in the Marine Corps League. I understand the DD Form 214 may contain information such as military awards, training, and character of service.
